### Invitation to an ETUI Education training course

Dear Trade Union Member,

The Education Department of the European Trade Union Institute (ETUI), in partnership with BNS (Romania) and DGB (Germany) will organise the training course "**Migrant Worker's Affiliation in Trade Unions**" that will be held on 4-5-6 February 2025 in Frankfurt, Germany.

# Background information and Objectives of the training

Migrant workers are frequently employed in sectors of the labour market with low union membership. Organizing these workers has been proposed as a strategy for revitalizing unions.

In its 2023-2027 Action Programme, the European Trade Union Confederation (ETUC) aims to promote campaigns that represent and affiliate migrant workers. To accomplish this goal, this training program has established the following objectives:

- Comparing the challenges and opportunities associated with the affiliation of migrant workers.
- Defining strategies for organizing migrant workers.
- Comparing trade union traditions in organizing migrant workers and sharing examples of best practices.
- Empowering the participation and representation of migrant workers within the union's structure.

#### Learning outcomes:

- Participants are equipped to develop strategies for organizing migrant workers.
- They identify challenges faced by unions in Europe.
- They facilitate democratic participation of migrant workers and strengthen their roles within union structures.
- They share best practices.

# Target group

- Shop steward or work council representative dealing with migrant's workers (active in union but not employed by union);
- TU officer or TU representatives working on the rights of migrants;
- TU officers or TU representatives in sectors where migrant workers are likely to be employed e.g. care, hospitality, cleaning, agriculture, construction, delivery;
- TU officers or TU representatives working as lobbyist or on policies issues related to migration.

How are enrolments processed?

The training course is open to 20 participants. The final confirmation of the participants will be done by ETUI and the team of trainers, considering the requirements for the target group. Priority will be given to members of BNS and DGB.

Please bear in mind the recommendations of the ETUC Action Plan for women, which call for the proportional representation of women in trade union activities.
