

Invitation to an ETUI Education training course

Dear Trade Union Member,

The Education Department of the European Trade Union Institute (ETUI), in partnership with LO-Sweden, and UGT (Spain), will organise the training course “**OSH, Climate Change and Green Transition**” that will be held from 21 to 23 January in Brussels, Belgium.

Background information

In December 2023, the ETUI Annual OSH Conference titled "Incoming challenges Ahead: Climate Change and Green Transition" explored the critical issues at the intersection of occupational health and safety, climate change, and the green transition.

Following the conference, this upcoming training will aim to improve trade unionists' preparedness for the potential effects of climate change and the green transition on workers' health and safety.

Objectives of the project

- Raise awareness about the effects of climate change and the green transition on occupational safety and health (OSH) risks.
- Identify changing hazards and new or intensified occupational risks associated with climate change and the green transition.
- Analyze approaches or tools to monitor the effects of climate change and the green transition on workers' health and safety.
- Develop preventive and protective measures to reduce the risks of workplace accidents and illnesses related to climate change and the green transition.

Target group

- OSH trade union officers and representatives at company or sectoral level.
- Trade union representatives responsible for environment, climate change, green transition and sustainability.

English, Swedish and Spanish
