The Education Department of the European Trade Union Institute is organising a workshop entitled: "Developing Emotional competence in Trade Union training". This workshop will take place in **Gif/Yvette**, **France** from **26 to 29 November 2024**.

Emotional Intelligence is the ability to identify, manage, and express emotions in various contexts. When we can recognise, accept, and effectively use our own and others' emotions, we develop emotional competence. Being emotionally competent involves essential social skills for recognising, interpreting, and positively responding to emotions in ourselves and others.

In Trade Union training, this approach to emotional intelligence is viewed collectively, considering the context of adult learning and the values that underpin our training principles at the European level. While not easy to grasp or practice daily, understanding and applying this concept is crucial for managing groups. It significantly enhances the effectiveness of group dynamics and learning processes in training settings. Therefore, managing emotions is vital in trade union training, both nationally and at the European level.

The pedagogical workshop will include sessions on self-awareness and emotional regulation, where emotional expression, develop vocabulary of emotional expression, and understand and utilise various tools such as Plutchik's wheel of emotions. One of the main objectives of this workshop is to include these issues in the design, preparation and implementation of our courses, and make it an essential competence to our trainers as well.

Aims

- **Identify** how emotions shape personal identity and relationships and strategies to improve these relationships;
- **Develop** self-awareness and self-management of personal emotions and other people's emotions;
- Analyze ways to enhance personal and group emotional intelligence through selfanalysis and reflective practices;
- **Recognise** emotions in others, responding to those emotions in order to inspire good development within a group;
- **Acknowledge** and **evaluate** the consequences of behaviour and weigh decisions before acting.
