Course Description

During this blended course participants will have the opportunity to better understand the EU Institutions, the decision-making processes, and the role Trade Unions can play to influence them in order to improve the impact of the trade union agenda at the European level, i.e. using campaigns and mobilisations, the EU institutions, employers and the social dialogue, allies in civil society, the Tripartite Social Summit, and EU external relations.

Aims

At the end of this course participants will be able to:

- To identify the role and responsibilities of EU institutions
- To recognise the EU policy-making process
- To understand the EU trade union structures and the way they work
- To analyse the impact of trade union action at the European level
- To develop advocacy skills and strategies to influence the decision-making process

Participants' Profile

Trade union officers from the ETUC affiliated organisations who are interested in EU-related issues, new officers at the international department, ETUC advocacy groups or permanent committees, ETUFs sectorial groups.

Working Languages

English, German and French.

Programme

The course is a blended course compound of two different parts the **online training course "EU for trade unionists"** that provides basic knowledge on European institutions that can be developed in 3-4 weeks. After that, we will have covered the basics and we can move forward to talk about advocacy and influencing the decision-making process in our **face-to-face course** that will take place in Brussels.

ONLINE TRAINING

Week 1 > Week 4:

From 28/10 - 26/11

You will be able to access to the online course and activities via the ETUI training platform. During this period you will cover the basics of European institutions, you will identify the worker representation system in the various EU countries, and outline the ETUC, its mission, structures, the role of its governing bodies, and also the EU ordinary legislative procedure.

- This first part of the course is self-paced: you will choose when to attend it.
- Online tutors will support participants during the training.
- This training activity, hosted on Moodle, is provided in English.

Workload

The online course will involve about **18 hours** of individual work.

- 4-6 hours/week during 4 weeks.
- The online course will be available in English, you will have documents in French and German.

Objectives

- To recognise the basic principles of the EU
- To identify the 5 essential elements of the European social model for the ETUC
- To identify the worker representation system in the various EU countries

- To outline the EU ordinary legislative procedure
- To define the fields of European social dialogue, describe their functioning and infer possible trade union actions
- To analyse, on the basis of a practical case, the principles allowing trade union action with a European scope
